RE: CAMPAGIN AGAINST THE INDUSTRIAL CONCILIATION AMENDMENT BILL.

As you are aware, the Management Committee of the South African Congress of Trade Unions has issued directives to all local Committees and affiliated Trade Unions in respect of the above Bill.

It has fallen upon our shoulders to smash the attempt by the Government to introduce the I.C. Amendment Bill; the reactionary. colour-bar and frightened Trade Union bodies have not urged the working people of South Africa to fight this Bill in any determined manner, nor have they shown real opposition to it.

Dear Comrade,

The National Executive Committee of the South African Congress of Trade Unions has given serious consideration to the present position of the workers and the Trade Union movement of South Africa.

It will be agreed that the promulgation of the Industrial Conciliation Act No. 28 of 1956 presents a new and complex situation to the workers. There is no doubt that the Act threatens to undermine the strength and unity of the Trade Union movement.

In addition, there is the growth of unemployment which, accompanied by the effects of the Industrial Conciliation Act on the Trade Union movement, constitutes a grave threat to the conditions and living standards of the workers of South Africa. It is said that there is no unemployment in South Africa because the figures of the Department of Labour show only minor fluctuations in the monthly totals of registration of unemployed workers. But these figures do not take into account the thousands of African workers who do not register with the Department of Labour.

My National Executive Committee is perturbed by the fact that, despite the adverse effects on all workers of the rising cost of living, (admitted even by the figures of the Department of Census and Statistics) there has been no adjustment of cost of living allowances by the Government since March, 1953.

We believe that these serious matters can only be dealt with successfully in the interests of the workers if there is maximum co-operation of the entire Trade Union movement. It is necessary to develop a common policy for the Trade Union movement which must be followed by concerted action.

In order to arrive at such a common policy, my National Executive

Committee suggests that a discussion Conference of Trade Union delegates be called as soon as possible.

We are at present engaged in preparing detailed, well-documented reports on the issues outlined above with a view to submitting these for consideration before such a Conference. However, we feel that the policies which such a Conference might work out will be immensely more effective if they really represent the consensus of opinion of the largest possible number of Trade Union representatives. For this reason I have been instructed to enquire whether your co-ordinating body will agree to convene such a Conference with us on the lines suggested above.

The proposed Agenda is as follows: -

- i) Industrial Conciliation Act No. 28 of 1956 and the Native Labour (Settlement of Disputes) Act as they affect the workers of South Africa.
- ii) Unemployment in South Africa.

We sincerely hope that in view of the serious problems facing the workers you will give this suggestion your most sympathetic consideration.

My National Executive Committee is open to any alternative suggestions which might assist in furthering the immediate needs and interests of the workers. At the same time I am to stress the importance of early action on these matters. We hope that your reply will not be unduly delayed.

The meeting of the Management Committee on 1st August, 1956, had to be adjourned as there was no quorum. One of the reasons for this was the fact that there was an emergency meeting of the Garment Workers' Union Executive Committee so that three members of our Committee were unavailable. However, as this is the second meeting which has had to be adjourned in the past month, we feel that the time has come for a serious assessment of the situation.

The Government has made its intentions with regard to all workers quite plain. Under the L.C. Amendment Act of 1956 and the Native Labour (Settlement of Disputes) Act it has the machinery at its disposal to destroy the Trade <u>Union movement in South Africa</u>. It is not necessary, at this point, to go into the history of the formation of S.A.C.T.U. but it is the only non-colour bar cular responsibility to all workers. Its tasks are to win over to its principles the mass of workers in the country; to organise the thousands upon thousands of unorganised workers; to advise; help, strengthen in every possible way its affiliated Unions; to weld all workers into a mighty force to fight the anti-worker policies of the Government.

The members of the Management Committee were elected because they had the confidence of the workers who regarded them as fit and responsible to carry out the tasks outlined above. What a sad reflection it is, therefore, that some of these members have not yet learned the most elementary lesson of Trade Unionism namely, the necessity of attending meetings. Non-attendance at meetings is excusable only in cases of severe illness or the absolute priority of other work (e.g. as with the Garment Workers' Union members mentioned above). There are no other excuses. If members of the MANAGEMENT COMMITTEE (the EXECUTIVE COMMITTEE of S.A.C.T.U.) are not disciplined nor responsible enough to understand this, the outlook for Trade Unionism in South Africa is bleak indeed.

It is a matter of great distress to us to write such a letter, but we would be failing in our responsibility to the workers if we did not take to task those members who have betrayed the trust placed in them by the workers they represent.

We wish to draw your attention to Government Gazette No. 5719; Gated 20th July, 1956, proclaiming that a Wage Board Investigation into the Milling Industry is to be held. The Board will sit at the following places and dates:-

- 1) Durban: In the Board Room, Department of Labour, Masonic Grove, off Smith Street, at 9.30 a.m. on 16th August, 1956.
- 2) <u>Cape Town</u>: In the Board Room, Department of Labour, Corporation Street, at 9.30 a.m. on 5th September, 1956.
- 3) <u>Swellendam</u>: In the Court Room, Magistrate's Office, at 10 a.m. on 7th September, 1956.
- 4) Port Elizabeth: In the Board Room, Department of Labour, Standard House, Queen Street, at 9.30 a.m. on 10th September, 1956.
- 5) Johannesburg: In the Board Room 222, Department of Labour, New Magistrates' Courts, Marshall Street, at 10 a.m. on 25th September, 1956.

For many years the progressive Trade Union movement has been engaged in organising Milling Workers. In the Transvaal the African Milling Workers' Union was established in 1943 and since the formation of the South African Congress of Trade Unions a Union has been established in Port Elizabeth.

This Wage Board investigation gives a great opportunity to improve the wages and working conditions of milling workers and the Management Committee urgently directs all Local Committees to throw in all their weight in rallying milling workers round their demands. In order to achieve the best possible results from this investigation, the Management Committee suggests the following:-

- a) Issue questionnaires as per attached copy to all milling workers to be completed and returned to S.A.C.T.U. or the Local Committee.
- b) Hold General Meetings of Milling Workers in your area and explain to them the position.
- c) At factory meetings of Milling workers elect delegates to be present at the hearing of the Board so that they can demonstrate their strength to the employers and the authorities.
- d) Obtain additional demands from workers for submission to the Wage Board.

We urgently request you to respond to this important directive and let us have a report as soon as possible. Within the next few days you will be receiving the demands of the Transvaal Milling Workers which, we trust, will be backed up nationally.
