Letter from M. Kotane to G. Hardy, 1 1 September 1936

Johannesburg.² 1st.9.1936.

Dear Comrade,

After our little talk, yesterday, I do not know where we are. I am sorry to have to say that I feel that I have been purposely muddled somewhere. Is it here or over there?³ Over there we were told the following:-

(a) No conference; that we must go and do some work first and then to call

a conference later to sum up the results of our work.

(b) That 90% of the Party membership must belong to the trade unions. And that the leadership of the Party must be composed of those Party members who work in the trade unions and those who are doing work among the Natives. That individuals who are not doing this kind of work, however loyal they may be to the Party, could not be in the leadership. That we must get Afrikaners, English and Natives in the Party – that these three must be the basis of the Party in this country.

(c) That we must set-up a properly functioning C.C.⁶ To my knowledge the idea of a Political Bureau was very much scorned at by them⁷ – they ridiculed the whole idea of a party like ours (a group of 150 people) having a political

bureau. We agreed with them on that.

(d) According to them the leaders⁸ of both sections are politically BANKRUPT. They suggested⁹ the following comrades for the leadership:-¹⁰

Wolfson, Mofutsanyana, Gomas and few others whom the Party may elect. TI

They strongly recommended to us the idea of a popular elected¹² and a representative leadership. But as their 'REP', ¹³ your ruling shall be final in this
