Our work in the youth movement where we have a number (or so⁹) Afrikanner youths and parall organisations of Native and coloured youths shows that all difficulties can be overcome with tact and the correct approach.

86 Report of R. Michel to A. Marty, 16 November 1937

REPORT ON MEETING IN PARIS ON OCTOBER 28TH.

Strictly confidential South Africa

Present: Comrades Marty, Hardy, Wolfson, Basner and Rosa¹ as secretary.

<u>Wolfson</u> submitted a resolution for the work of the South African Party which he had just written in London after the discussion in the special commission and in the British PB.

He declared that he had never seen the resolutions of the ECCI of March 1937² on the South African questions, neither in South Africa nor in London and only saw a 'resolution on the situation of the people in South Africa'.³

<u>Hardy</u> declared to have only got the inner resolution but not the other one which was not included in the package. He turned everything he had re South

Africa, to the British Party, as he was informed he would not return to S.A. He is now working for the British Party.

 $\underline{\text{Basner}}$ declared to have seen a document in which it is said to finish the factional fight.⁵

<u>Hardy</u>: in order to help the South African Party, the British Party has sent two letters to them which were in the spirit of the resolution of the ECCI. He was of the opinion that the South African comrades should write the resolution themselves; that is the reason why Com. Wolfson was appointed by the PB to do.

Answering the remark of Comrade Marty that the new resolution does not give the proper place to the work among the Natives, Hardy answered: the resolution was orientated towards the short objective of the elections and the task of winning the decisive strata of the population, of organising a broad electoral front, as a loose organisation without an organised body. But nevertheless he agreed that the national question has not been dealt with in a correct way in the resolution.

<u>Basner</u> declared that he did not agree with the resolution. His declaration took place at the end of the above mentioned exchange of views.

Then there was an exchange of views on personal questions. Comrade Marty asked Basner his views re Roux-Gomez-Kotane. Basner answered: Gomez and Kotane can be put into one category. Roux stands in another. Gomez and Kotane are strong nationalists. Roux is a typical chauvinist intellectual, a university professor, more interested in the national movement than in the Party. He is very emotional.

Kotane is a clever man with a just understanding, but as the Communist Party is constructed now, he cannot work within it. He does not want to break sharp with the Party, but wants to start a new national movement together with Kotane. I have respect for Kotane. He is a nationalist. He understands that the Party line is correct but he cannot work with the Party. Roux' wife talks the same language as the Trotskyists. She left the Party three years ago, after getting a post as teacher in a government school. Roux is a very honest man, but he cannot think in a Marxist way. When he is alone he comes back to idealistic positions.

Gomez is a worst type. Not so honest, does not understand so much.

The three people are not at all connected with the trade union movement. Kotane is still publishing his magazine 'UMWIKILI TEBELE'. Roux was taken off the PB.

In Capetown, the connections with Gomez are very close. Gomez, Emmerich and Weinberg are secretaries in Capetown.

<u>Wolfson</u>: May be Gomez has something else on his mind, but his policy is on the line of the Party. In Johannesburg there is no opposition to the Party. Marks is the former secretary of the Party.

<u>Basner</u>: Marks is an enemy of the working class. He made open provocations. Natives have to complain on his attitude towards them.

<u>Decided</u>: Hardy, Wolfson, Basner to return to London and get new contact with the commission and to ask for the resolution of the ECCI. A new resolution should be written on the basis of the resolution of the ECCI of March 1937⁹ and take into account the changes in the situation. Since that time Com. Wolfson and Basner were to return to Paris and submit the new resolution to Com. Party. ¹⁰

On November 3rd Comrades Wolfson and Basner came back. They were accompanied by Comrades Hardy and Kerrigan. No report on this meeting yet.

REPORT ON PARIS DISCUSSIONS.

On Tuesday morning I arrived and saw Comrade M.¹ Only B.² of the other comrades was available. (It transpired that the fog had held W.³ up in the channel and he and H.⁴ arrived late Tuesday).⁵

On Tuesday I explained to Comrade M. that our P.B.⁶ had understood their Commission from the Centre⁷ to be to work out together with our friends from S.A. the line which would help them in the next period to develop the Party,
